1. Data Controller

Your personal data may be processed by İskenderun Enerji Üretim ve Ticaret A.Ş. ("ISKEN" or "Company") as the data controller pursuant to Law No. 6698 on the Protection of Personal Data ("Law") and the Communiqué on the Information Security Management System and the Procedures and Principles to be followed in the Fulfilment of the Disclosure Obligation, within the scope described below.

2. Purposes of Processing Personal Data

- Providing private security according to Law No. 5188 to ensure physical space security,
- Ensuring the security of our Company's building and facilities against any inconvenience,
- Ensuring commercial and labour security, and
- Recording and following-up the visitor logs; informing authorized persons and institutions when necessary.

3. Transfer of Personal Data and Purpose of Transfer

Your personal data described in Article 2 of this Privacy Statement, within the purposes specified in the same article, may be transferred to the legally authorized public institutions and the legally authorized private institutions (domestic or abroad) within the scope of the personal data processing conditions stated in Article 8 of the Law, depending on and limited to the reasons requiring transfer within the scope of the Law and the relevant regulations, provided that adequate measures are taken.

4. Method and Legal Ground for Processing Personal Data

Your personal data are processed verbally, in writing or electronically through the information and documents provided by you in connection with your visit and limited to the purposes specified in this Privacy Statement, in accordance with the reasons specified in Articles 5 and 6 of the Law (which are given below);

- To be explicitly stipulated in the laws,
- To be mandatory for the fulfilment of our legal obligations,
- To be mandatory to process data for the establishment, exercise or protection of a right, and
- To be necessary for our legitimate interests, provided that it does not harm your fundamental rights and freedoms.

5. Your Rights Regarding the Protection of Personal Data

We hereby inform you that you have the following rights pursuant to Article 11 of the Law:

- To learn whether or not your personal data are being processed,
- To request information if your personal data have been processed,
- To learn the purpose of the processing of your personal data and whether they have been used accordingly,
- To learn which third parties domestic or abroad your personal data has been transferred to,
- To request rectification in case your personal data has been processed incompletely or inaccurately
- To demand the erasure or destruction of your personal within the conditions stated in Article 7 of the Law,
- To demand notification of the correction, deletion and destruction made to third parties with whom your personal data are shared,
- To object if negative consequences have arisen for you as a result of analysis of the processed personal data through solely automatic systems,
- To demand compensation for the damages that you have suffered as a result of unlawful processing of your personal data
